#### **Communications with Government Officials**

This area is addressed on page 10 in the context of the *Emergency Response Plan.* Nonetheless, we emphasize on the importance of establishing effective communication channels with Government Officials such as Majors, not only in the event of an emergency, but in all circumstances. The events that transpired this week as a result of the weather disturbances currently impacting the island buttress the P3A position that it is of utmost importance for LUMA to promptly coordinate for direct and effective communication with Government Officials. Please provide information on how this communication is being handled to ensure all Majors are being assisted. Additionally, LUMA's points of contact for Majors and municipalities.

Finally, while the P3A acknowledges that LUMA has designated Mrs. Laura Rentas, its Communications Director, to be the single point of contact person for all stakeholders requests, we strongly encourage you to designate a Spanish-fluent speaking spokesperson with experience in handling the press and issues management, given the impact of the transaction and overwhelming amount of media attention and information requests.
